- Utilised TfC's 'Unit Costing' tool
- 1 of 9 pilot authorities
- Project Manager seconded to oversee
- Commenced in February 2010







# Approach

- 14 Children's Centres
- All activities within a centre measured
- All partner agencies included
  - commissioned
  - contributed
- Reconciliation of total Sure Start grant
  - including infrastructure

- Cost per delivered activity
- Cost per beneficiary attending
- Cost per hour of delivery
- Cost per session
- Added value of contributed staff
- Cost of commissioned services
  - per centre
  - per child


