

### What young people say

 Ofsted review of special educational needs and disability 2010 The voice of young people comes across in the review, making it clear what they want for the future;

"successful relationships and friendships; independence, including choice about whom they lived with; choice about what to do with their spare time; and the opportunity to work."



### TSP 5 focus areas – local and national are still the same...

- Council for disabled children
- Participation of disabled young people and their families
- Effectiveness of personalised approaches
- Joint assessments processes within children's trusts and adult services
- Realistic post 16 opportunities for living life
- Strategic joint partnership working







#### **Oldham**

- Young people to have their own home, access mainstream facilities and live in the community
- Young people moving back to Oldham from out of borough placements
- Is changing expensive and unsatisfactory 'fire fighting culture' for those young people moving back into Oldham from out of borough placements.





### Warwickshire

- Data gathered from year 8 meetings and case planning meetings in Warwickshire is used to inform commissioners within adult services of gap in services for young adults in transition with autism.
- This has led to the development of:
- A clear assessment pathway
- An autism broker service
- The Learning Disability team within Adult Services now takes the lead in assessment of young people with ASC under Fair Access to Care. Those who do not meet the FACS criteria may now be referred to the autism broker service for low level preventative support.



### North East Lincolnshire My Life, My Choice, My Future



Network

- People with a learning disability aged between 14 and 70 can request support to develop a person centred plan (PCP).
- By using this more disabled young people are getting outcomes they want - many using individual budgets or direct payments
- Local authority and local service providers can develop skills to meet identified aspirations/outcomes
- EG: Schools identify what their pupils' priorities are within and outside school –

Curriculum development

After school activities, accessing community activities

Practical skills like travel training

Commissioners identify opportunities for community inclusion –

development of community based activities tailored to individual requests/interests

## Aiming High for Disabled Children – what has changed?



- Consolidate voice of parents
- Huge bank of evidence on effective ways of working – from all partners – part of work now to disseminate
- Shift from 'dealing with' to 'working with'
- Positive outcomes for all young people not seen as outlandish
- Disabled children, young people and families high in coalition policy development
