# Nine Generic Return to Practice Learning Outcomes (NMC,2008):

- 4. Current issues

- 6. Assess need, design & implement interventions, evaluate outcomes
- 7. Communication, teaching and learning skills
- 8. Team working/multi-professional approach
- Identification of strengths & weaknesses,
   Limitations and professional development

### Framework (DH,2011)

- Provide opportunity for lapsed Specialist Community Public Health Nurses (SCPHN) to achieve the knowledge, skills and competence required by the NMC to be fit for practice/return to practice as a SCPHN(HV) in the UK
- To suggest ways of achieving learning outcomes linking with fitness for purpose
- Provide some consistency to the development of programmes and practice across the UK, and to support students in achieving learning outcomes
