## Why Philanthropy?

- Provides support that supplements other funding streams
- Nothing New
- Economic Environment
- HEFCE : encourage growth of philanthropy in HE







#### Role of institutional leadership:

- Decide its important
- Learn what good fundraising looks like
- Get Senior staff on board
- Invest in skilled staff and training for senior academics
- Determine strategy for the institution ...and the role of philanthropy in its delivery



#### The Vice-Chancellor's Role in Advancement

- Internal Champion
- External advocate/Chief fundraiser
- Articulate vision
- Events, personal visits, connections to alumni
- Clear expectations of advancement team
- A donor to the institution





#### **Expanding the Reach of Leadership Beyond the Vice-Chancellor**

- Involvement of Academic Leadership—specifically Deans, heads of Schools or Departments
- The creation of structures for volunteer involvement
- Working with Student leaders
- Create Advancement committee (council subcommittee)
- Embed advancement in annual development plans








# **Challenges of Implementing and Growing Capacity**


- Development is a long-term initiative
- Changes are needed internally:
  - Creation of Gift Oversight Committee
  - Alignment of institutional priorities with donor communications
  - Create Links between DARO and Schools/Depts
- and externally:
  - > Educate alumni about giving
  - > Creation of volunteer opportunities and involvement








### **Loughborough Performance of All Institutions**

## **Understanding Donors**

#### The review will:

- Consider what motivates donors to give to HE
- Reveal the barriers and incentives to giving to HE
- Help us to understand the impact of economic changes on donors to HE
- Recommend initiatives to remove barriers to increase philanthropic support to HE



#### Government initiated incentives to giving to HE

#### The review will

- Analyse the learning from the matched funding scheme, has it achieved objectives?
- Analyse the role of tax incentives in encouraging gifts to HE, what else can be done to incentivise giving?
- Consider the Green Paper on Giving in relation to HE, can we learn lessons from other sectors?



#### The impact of Philanthropy on HE

#### The review will:

- Demonstrate the beneficial impact of philanthropy on HEI's, their staff and students,
  showcasing examples at all levels of giving and within all types of institutions
- Uncover the pitfalls and examine how these can be avoided



#### **Changes required by HEIs**

#### The review will:

- What are the critical factors that lead to sustained success in development programmes?
- Address how philanthropic culture is organised and embedded in institutions
- Review the capacity building programmes delivered by CASE Europe
- Consider workforce implications ...insufficient fundraising staff in HE?
- Identify other areas of good practice



#### **Review Process**

- Open consultation managed though More Partnership, with responses encouraged from all UK HEIs, now live
- A series of in depth interviews with selected institutions of different backgrounds and experience in philanthropy
- Interviews with donors and other stakeholders (UUK, CASE Europe, Government)
