Initial Guidance

White Paper 12/7/10 - 4 Functions

- To Assess the Needs of the local population and lead the JSNA
- To promote integration and Partnership across areas, including through promoting joined up commissioning plans across the NHS, Social Care & Public Health
- To support joint Commissioning and pooled budget arrangements
- To undertake a scrutiny role in relation to major service redesign

Initial Guidance

- Statutory obligation for LA and NHS Commissioners to serve on HWB and act in Partnership
- Focus on Health Improvement, reducing health inequalities, integrated working across care pathway
- Requirement for upper tier local authority areas
- Subject to legislation, HWB assume powers and duties in April 2013
